**THIS IS THE TOTAL AMOUNT FROM THE START TO FINISH FOR A SUCCESSFUL ADOPTION. THIS INCLUDES FINALIZATION. IF YOU DO NOT WISH TO HAVE THE ADOPTION FINALIZED IN THE STATE OF FLORIDA, YOU WILL HAVE TO COVER THE ADDITIONAL COSTS TO HAVE AN ATTORNEY OF YOUR CHOICE FINALIZE THE ADOPTION IN YOUR HOME STATE: PLEASE INITIAL \_\_\_\_\_**
